



CSI de Peelbergen is organized in accordance with the FEI requirements:

Additional information regarding CSI de Peelbergen can be found below. The measures and rules are not optional. Equestrian Centre de Peelbergen is only able to organize a CSI in the safest way possible when all guests follow the instructions. Thank you for your attention and cooperation!

## **1. BEFORE TRAVELLING TO PEELBERGEN**

- 1.1. Monitor and record the temperature of each of your horses twice a day for the 10 days leading up to the event (starting immediately if the event starts in less than 10 days) on the [Temperature Record Sheet \(annex 1\)](#).
- 1.2. Fill in the attached [FEI Equine Health Self-Certification form \(annex 2\)](#) and keep this form in the horse's passport.
- 1.3. Pack a thermometer and maybe a back-up thermometer too.

## **2. UPON ARRIVAL AT PEELBERGEN**

- 2.1. Park your truck at the directions of our parking attendants.
- 2.2. If you have a negative COVID-19 test certificate (the official test results must be less than 72 hours old. Self-tests are not permitted), please proceed to the accreditation point.
- 2.3. If you do not have a negative COVID-19 test certificate, please proceed to the COVID-19 test area located on the parking lot by foot. Here you can get tested (cost per test €50 euro excl. VAT).
- 2.4. At the accreditation point provide your negative COVID-19 certificate and your ID. After you've been given accreditation, you are allowed to enter the stable area. Please proceed to the stable managers office to check in. Here you will receive your Horse registration form, stable numbers, breakfast tickets and electricity ticket.
- 2.5. Now it is time to unload your horses (not your equipment!) and place your horses in the allocated stables (with or without first bedding). Please note that in the tents there is a one-way routing for the horses!
- 2.6. Fill in the Horse registration form and return the form to the stable managers office and place it in the designated box. This will prompt a veterinarian to come and check your horses. Wait at the stables and have your horses' passports, Equine Health Self-Certification form and thermometer ready.
- 2.7. If your horses are deemed acceptable by the veterinarian, you may unload your equipment. If your horse is not accepted, it will undergo a specific protocol in compliance with FEI VRs and flow chart.
- 2.8. At every horse stable we have provided a Temperature record sheet. Please fill in the required contact details and note the twice daily temperature checks on this sheet.



### **3. GENERAL RULES AT PEELBERGEN**

- 3.1. In the stables the stall doors must be closed at all times.**
- 3.2. Note that every rider can bring a maximum of 2 persons (every person needs to present a negative COVID-19 test certificate at the accreditation point). Please see no. 2.2. & 2.3 on this paper.
- 3.3. According to the FEI rules horses require a negative PCR test when entering shows that accept over 400 horses. This is applicable during week no. 2 of the Spring Tour and the CSIO3\* in June! There will more than 400 horses accepted at these shows.**
- 3.4. In all the inside areas (stables, pavilion, toilets, take-away point etc.) it is mandatory to wear a face mask. If you do not have a face mask, you can buy them at the stable managers office.
- 3.5. **Trucks & grooms may only arrive Wednesday between 10h00 – 16h00.**  
You may not come earlier to prepare the stables etc.
- 3.6. On Wednesday flatwork can be done in the outdoor warming-up arena. Thursday – Sunday flatwork is only allowed in the indoor arena.
- 3.7. From 07h00 – 10h00 you can lunge in the indoor arena; outside these times lunging is only allowed in the outdoor lunge pens.
- 3.8. To minimize the risk of any virus spreading, all dogs must be leashed and be accompanied by a human or tied to stationary object. Violation of this rule means you will receive a €100 euro fine. No warnings will be given.
- 3.9. There are still COVID-19 measures in place in the Netherlands. This means we will provide a full catering service for all our guest with several take-away points and limited indoor seated areas available for eating and drinking.
